KEF Holdings is a privately-owned family company, headquartered in Dubai International Financial Centre (DIFC), UAE – steeped in more than 25 years of success and shaped by a mission to be different and make a difference. It is a diversified company known for establishing technologically integrated enterprises across multiple industries. In 2007, they set up the ETC Community Centre which Dubai International Capital (DIC), the investment arm of the government-owned Dubai Holding, acquired a 45 percent stake in Emirates Techno Casting for \$126 million in 2008. In 2011, Tyco International announced it completed the acquisition of 75% equity stake in Emirates Techno Casting, worth US\$300 million, including the stake originally acquired by DIC. Tyco further acquired the remaining 25% stake, held by Kottikollon, for an additional US\$100 million. He belongs to Pouducherry and resides in Dubai, his estimated net worth was \$310 million in 2018.
